**FINAL ORDER GRANTING DEBTOR'S MOTION FOR ENTRY OF
AN ORDER AUTHORIZING THE DEBTOR TO MAINTAIN
EXISTING INSURANCE POLICIES AND PAY ALL POLICY
PREMIUMS ARISING THEREUNDER**

Upon the motion (the "**Motion**")¹ filed by the above-captioned debtor and debtor-in-possession (the "**Debtor**") seeking entry of an order authorizing the Debtor to pay pre-petition Policy premiums, if any, necessary to maintain in effect current insurance coverage; and the Court, having reviewed the Motion and having heard the statements of counsel in support of the relief requested in the Motion at the hearing before the Court (the "**Hearing**"), finds that the Court has jurisdiction over this matter under 28 U.S.C. §§ 157 and 1334, that this is a core matter under 28 U.S.C. § 157(b)(2), that notice of the Motion and the Hearing were sufficient under the circumstances and that no further notice need be given; and the legal and factual bases set forth in the Motion and at the Hearing establish just cause for the relief granted herein and that such relief is necessary to avoid immediate and irreparable harm to the Debtor's estate,

THEREFORE, IT IS HEREBY ORDERED THAT:

1. The Motion is GRANTED as provided herein on a final basis.
2. The Debtor is authorized, but not required, to honor the terms of its existing Policies and to pay all pre-petition premium payments related thereto.
3. To the extent that the Policies or related agreements may be deemed executory contracts within the meaning of Section 365 of the Bankruptcy Code, the Debtor does not at this time seek authority to assume such contracts, no relief is granted in respect thereof, and no determination is made as to whether any such contracts are executory.
4. Notwithstanding Bankruptcy Rules 6004, 7062, or 9014, the terms and conditions of this Order shall be immediately effective upon its entry.
5. The Court retains jurisdiction with respect to all matters arising from or related to the implementation of this Order.
