PLEASE TAKE NOTICE VidAngel, Inc., the above-captioned debtor and debtor in possession (the “**Debtor**”) has filed with the United States Bankruptcy Court for the District of Utah (the “**Court**”) its Motion to Employ Stris & Maher LLP as Special Counsel under Section 327(e) of the Bankruptcy Code (the “**Motion**”), and that the Court has reserved a hearing (the “**Hearing**”) before the Honorable Kevin R. Anderson on the Motion on January 9, 2018 at 10:00 AM in the above-referenced Court located at 350 South Main Street, Salt Lake City, UT 84101, Courtroom 376.

YOUR RIGHTS MAY BE AFFECTED. You should read these papers carefully and discuss them with your attorney, if you have one in this chapter 11 case. If you do not have an attorney, you may wish to consult one.

Relief Requested. By the Motion, the Debtor requests entry of an order authorizing the Debtor to employ Stris & Maher LLP (“**Stris & Maher**”) as special counsel to represent the Debtor in its pending appeal to the Ninth Circuit, where the Debtor is seeking reversal of the district court’s order in *Disney Enterprises, Inc., et al v. VidAngel, Inc.*, No. CV 16-04109-AB (PLAx), granting final partial judgment on the Debtor’s counterclaims asserted in the action.

NO HEARING WILL BE CONDUCTED ON THE MOTION UNLESS A WRITTEN OBJECTION IS FILED WITH THE CLERK OF THE COURT ON OR BEFORE THE OBJECTION DEADLINE SET FORTH BELOW.

If you or your attorney do not take these steps, the Court may decide that you do not oppose the relief sought in the Motion and may enter an order granting the requested relief. In the absence of a timely filed objection, the undersigned counsel may and will ask the Court to enter an order approving the Motion without holding the Hearing.
