**ORDER SETTING SUPPLEMENTAL BRIEFING DEADLINE AND FINAL
HEARING ON MOTION FOR RELIEF FROM THE AUTOMATIC STAY
PURSUANT TO 11 U.S.C. § 362(d) (DOCKET NO. 69)**

On August 28, 2018 the Court held a status conference on Disney Enterprises, Inc., Lucasfilm Ltd. LLC, Twentieth Century Fox Film Corporation, Warner Bros. Entertainment Inc., MVL Film Finance LLC, New Line Productions, Inc. and Turner Entertainment Co. (the “Movants”) Motion for Relief from the Automatic Stay Pursuant to 11 U.S.C. § 362(d) (the “Motion for Relief from Stay”). *See Docket No. 69*. Michael R. Johnson, Rose Ehler, and Kelly Klaus appeared on behalf of the Movants. Tom Beckett, Brian Rothschild, and Grace Pusavat appeared on behalf of VidAngel, Inc. Laurie Cayton appeared on behalf of the United States Trustee. The Court heard brief oral argument from the parties. The following matters were discussed and scheduled. Times and deadline set forth herein may not be modified without the approval of the Court or consent of the parties and on a showing of good cause. Therefore, the Court **HEREBY ORDERS**:

1. **WITNESSES AND EXHIBITS:** A final list of witnesses and exhibits shall be filed with the Court no later than **October 10, 2018**. A final set of exhibits and witnesses shall be lodged with the Courtroom Deputy (Judianne Genovese, Anderson_Chambers@utb.uscourts.gov) **no**

later than October 10, 2018 at 4:30 p.m. Counsel shall provide the Courtroom Deputy with these documents pursuant to the following directives:

- (1) An original and one (1) hard copy of all exhibits bound and tabbed with a cover page. All exhibits shall be marked for identification by the Courtroom Deputy.
- (2) An electronic copy of all exhibits in .PDF format with searchable text enabled, and preferably with a table of contents with bookmarks or links to each exhibit. The PDF copy of the exhibits may be emailed to the Courtroom Deputy using the email address listed above.
- (3) A list of witnesses with correct spelling of the witnesses' full names.

Unless permitted by the Court at the hearing for good cause shown, no witness whose name has not been provided hereby shall be permitted to testify at the hearing and no exhibit that has not been exchanged and specifically identified as required hereby shall be admitted into evidence at the hearing.

2. **UNDISPUTED FACTS:** The parties may file a statement of contested and uncontested facts no later than **October 10, 2018**
3. **ADDITIONAL BRIEFING:** The parties may each file an initial brief no later than **September 14, 2018**. The parties may each file a brief in response to the initial briefs no later than **September 28, 2018**.
4. **EVIDENTIARY HEARING:** A final hearing on the Motion for Relief from Stay shall be held on **October 17, 2018 at 1:30 p.m.** before the Honorable Kevin R. Anderson, United States Bankruptcy Judge, Room 376, Frank E. Moss United States Courthouse, 350 South Main Street, Salt Lake City, Utah. The hearing is set for **3.0 hours**.
