3. The Debtor, after deducting previous payments to RMA, is authorized and directed to pay the balance of compensation and reimbursement in the amount of amount of \$11,372.00 for the balance of fees incurred to RMA upon entry of this order.
4. The Application is approved without prejudice to RMA's right to seek further compensation and reimbursement under any subsequent fee application.
