PLEASE TAKE NOTICE that George Hofmann, in his capacity as the chapter 11 trustee (the "Trustee") of VidAngel, Inc. (the "Debtor"), through counsel, filed with the United States Bankruptcy Court for the District of Utah the *Trustee's Motion for Order (i) Fixing a Bar Date for Filing Applications to Allow Administrative Expense Claims of Debtor's Professionals; (ii) Approving the Form of the Bar Date Notice; and (iii) Approving the Mailing Procedures* (the "Motion") on September 13, 2019. (2) attend a hearing to be held with respect to the Motion, which is set for **October 8, 2019 at 10:00 a.m.**, United States Bankruptcy Court, 350 South Main Street, Salt Lake City, Utah 84101 in **Courtroom 376**. **There will be no further notice of the hearing** and failure to attend the hearing will be deemed a waiver of your objection.

If you or your attorney do not take both of the above-described steps, the Bankruptcy Court may decide that you do not oppose the relief sought in the Motion and may enter an order granting that relief. In the absence of a timely filed response to the Motion, the undersigned counsel may and will ask the Court to enter an order approving the Motion without hearing.
