PLEASE TAKE NOTICE that Call & Jensen (the "Applicant") has filed its **Application of Special Litigation Counsel Call & Jensen, P.C., for Payment of Attorney's Fees and Costs for the Period January 1, 2019 through July 31, 2019** (the "Application"). The Application seeks allowance and payment on an interim basis of compensation in the amount of \$879,470.00 for services rendered and reimbursement of out-of-pocket expenses in the amount of \$50,789.47. The Application is available online from the Bankruptcy Court's electronic case docketing system, or upon written request to the undersigned counsel.

If you do not want the Court to grant the relief requested in the Application then you or your lawyer must:

(2) attend the hearing to be held with respect to the Application, which is set for **October 29, 2019 at 10:00 a.m.**, United States Bankruptcy Court, 350 South Main Street, Salt Lake City, Utah 84101.

If you or your attorney do not take both of the above-described steps, the Bankruptcy Court may decide that you do not oppose the relief sought in the Application, and may enter an order granting that relief. In the absence of a timely filed response, the undersigned counsel may ask the Court to strike the hearing and enter an order approving the relief sought through the Application without hearing.
