PLEASE TAKE NOTICE that George Hofmann, in his capacity as the Chapter 11 Trustee (the "Trustee") of VidAngel, Inc. (the "Debtor"), has filed his Amended Motion to Modify Plan (the "Motion"). Through the Motion, the Trustee seeks entry of an order approving his proposed modifications to his Plan of Reorganization (the "Plan") for the Debtor. A copy of the Motion is included herewith, and the proposed modifications are summarized in the Motion and shown in more detail in the "Redlined Plan" attached as Exhibit A to the Motion.

YOUR RIGHTS MAY BE AFFECTED. You should read these papers carefully and discuss them with your attorney, if you have one in this bankruptcy case. If you do not have an attorney, you may wish to consult one.

If you do not want the Court to grant the relief requested in the Motion then you or your lawyer must:

for Disney Enterprises, Inc., Lucasfilm Ltd. LLC, Twentieth Century Fox Film Corporation, Warner Bros. Entertainment Inc., MVL Film Finance, LLC, New Line Production, Inc. and Turner Entertainment Co. (collectively, "Copyright Creditors"), file with the Bankruptcy Court a written response to the Motion, explaining your position, by no later than July 28, 2020, pursuant to the *Stipulated Order Fixing Procedures and Deadlines for Discovery, Experts, and Confirmation Hearing*, entered on July 7, 2020 [Docket No. 756].

and

(2) attend the hearing to be held with respect to the Motion, which is set for **August 26, 2020 at 10:00 a.m.**, United States Bankruptcy Court, 350 South Main Street, Salt Lake City, Utah 84101, Courtroom 376.

If you or your attorney do not take both of the above-described steps, the Bankruptcy Court may decide that you do not oppose the relief sought in the Motion, and may enter an order granting that relief. In the absence of a timely filed response, the undersigned counsel may ask the Court to strike the hearing and enter an order approving the relief sought through the Motion without hearing.
